UNF Poll: Waters in Modest Lead vs Burton for Jacksonville Sheriff Bean ahead of Holloway for U.S. Representative for Florida's 4<sup>th</sup> District

A new poll of likely voters in Duval County from the Public Opinion Research Lab (PORL) at the University of North Florida shows Republican candidate for Jacksonville Sheriff T.K. Waters with a five-point lead over Democrat Lakesha Burton.

Registered, likely voters in the November 8 midterm election were asked their vote choices in the upcoming election. Duval County residents were asked about the Jacksonville sheriff and 2023 mayoral elections, while residents of Florida's 4<sup>th</sup> Congressional District (CD 4) were asked about the election for U.S. Representative.

When asked their vote choice for Jacksonville Sheriff, 48% of respondents said they would vote for Republican T.K. Waters, with 43% for Democrat Lakesha Burton. Nine percent said they did not know or refused to answer.

"This race has gotten a lot tighter since the first election back in August when T.K. Waters came in with a 14-point lead," commented Dr. Michael Binder, PORL faculty director and UNF professor of political science. "It's important to note that a good portion (12%) of likely Democrat voters either don't know or refused to say who they're voting for, and if they end up voting party lines, it could boost Burton's chances."

Duval County respondents were also asked their vote choices in the March 2023 election for Jacksonville mayor. All candidates that have filed to run were included in the list of responses for the 2023 election. Democratic candidate Donna Deegan came in with the greatest support at 22%, followed distantly by Republican Daniel Davis with 7%, and Democrat Audrey Gibson with 6%. Forty-seven percent of likely voters said they don't know or refused to answer, which was by far the most popular response. "The mayoral election isn't until March of next year so these numbers will change significantly over the next five months," stated Binder. "Donna Deegan seems to have maintained a comfortable lead since earlier this year, but with a whopping 47% who don't know—53% of registered Republicans—it is still anyone's race."

A separate sample of residents of Florida's newly re-drawn 4<sup>th</sup> Congressional District were asked their vote choices for U.S. House Representatives. Fifty percent of respondents said they would vote for Republican State Senator Aaron Bean, with 38% for Democrat LJ Holloway, 12% said they did not know or refused to answer.

"This race has been on a lot of folks' radar since CD 4 was redrawn earlier this year, especially given legal challenges and criticism of the new districts as watering down the Black vote in North Florida," said Binder. "Not only has LJ Holloway likely feeling some of these redistricting effects as a Black Democrat, but she's also been far outspent by Aaron Bean on the campaign trail."

#### Methodology

The UNF PORL Jax Speaks Poll was conducted from October 20 through October 27, 2022, by the Public Opinion Research Lab (PORL) at the University of North Florida, and consists of two separate random samples: 531 registered, likely voters in Duval County, and 413 registered, likely voters in Florida's 4<sup>th</sup> Congressional District. A voter was considered "likely" if they met the following criteria: 1. they voted in the 2018 midterm general election and/or the 2022 primary election; OR 2. they registered to vote in Florida in 2020 or later. Respondents who indicated they would *definitely* not vote or *probably* not vote in the upcoming election were screened out of the survey. The sampling frames were sourced from the Florida voter file. To ensure a representative sample of likely voters, the samples was stratified into eight geographical regions based on House District.

Respondents were contacted by live callers via the telephone between 12:30 and 9:00 p.m. daily with up to three callbacks attempted. PORL interviewers administered surveys in both English and Spanish. Data collection took place at the PORL facility with its 27-station Computer Assisted Telephone Interviewing (CATI) system. A single interviewer, through hand dialing, upon reaching an individual by phone, asked the listed respondent by name. If the respondent was not available, the call was terminated. This Duval study had a 6.6% response rate, and the CD 4 had a 7.5% response rate, using the American Association of Public Opinion Research (AAPOR) Response Rate 3 (RR3) calculation.

The weighting process had three steps. First, data were weighted by geographic strata to reflect the population of likely voters in Duval County and CD 4, followed by educational attainment. Finally, data were weighted to partisan registration, age, race, and sex. Education weights were created from the Census Bureau's American Community Survey (ACS) 2020 5-year estimates for individuals 25 and over. Partisan registration, sex, race, and age weights were created from the October 2022 update of the Florida Voter File to match likely voters in each sample. All weighted demographic variables were applied using the SPSS version 27 rake weighting function, and are assigned a weight if one of the demographics being weighted on is missing. The margin of sampling error for the Duval County sample is +/- 4.7 percentage points, and for CD4, +/-5.4 points, including the estimated design effect.
